Campaign for Red Diesel

As you may be aware the government has come down on the side of the campaign to apply for the derogation on red diesel to be extended beyond 2006. It would appear that the decision by the Eurocrats will be a case of horsetrading with the newer members of the EU.

These extracts show some interesting developments.

UK government prepares case for keeping red diesel derogation. 2006 March 17

The UK government has drafted a Regulatory Impact Assessment (RIA) concerning the expected results of ending the EU derogation that allows lowtaxed red diesel to be used for pleasure craft propulsion.

The conclusion of the document

is "that the balance of advantage lies with retaining the derogation. Its removal would cause market distortion and would have significant compliance costs for both the industry and the Government."

In UK, high-taxed (white) diesel currently sells for about three times the price as red diesel.

UK is forming a common cause with the other EU member states that currently have such a derogation -- Belgium, Finland, Ireland, and Malta

Biodiesel to be tested on the Broads. 2006 March 3

The Broads Boat Hire Federation has announced a two-year project to test the use of biodiesel in pleasure craft. 40 boats, from a variety of hire fleets, will be run on fuel from recycled vegetable oil, and the results will be compared with those of control boats using mineral diesel.

The biodiesel will be commercially produced by Global Commodities of Dereham, from waste cooking oil.

Previous research by Newcastle University on emissions from boats using biodiesel has shown a significant reduction in pollution. The use of waste cooking oil keeps it out of the sewers, where it can cause clogging and other problems.

The price of the biodiesel will be higher than that of red diesel, but significantly lower than that of white diesel. Discussions are underway with HM Revenue & Customs to confirm the applicable duty rate.

The Presidents Piece

_Firstly I would like to extend a warm welcome to our new editor of Porthole Lynn Mortlock who has kindly volunteered to undertake this important communication function, and to thank Sally Robinson for her past contribution in this role.

There are a number of pressing issues to update to the membership as follows:-

Beningborough beach.

The mooring prohibition announced by the National Trust (NT) at this important location is subject to challenge by me in the name of the Boating Association. This dispute is now nearly a year old the delay in reaching a solution being due to nil response by BW and thus far a slow response by the NT.

I have however recently received both written and verbal contact from the NT in what I regard as conciliatory terms. NT is reviewing their decision and there is to be a site meeting at Beningborough involving the interested parties on a date yet to be determined. I now therefore ask for at least one volunteer from the membership to accompany me on that occasion when announced.

In the mean time I would advise members if challenged when mooring at Beningborough to calmly assert their right to moor at the old ferry landing and gain access to the tow path. Alleged confrontation is said by NT to be the cause of the mooring ban any such suggestion should therefore be avoided in the run up to negotiations.

I would like to thank Christine Baldock for her help in researching the history of the disputed mooring which unmistakably is the site of the ferry landing from Nun Monkton also the point at which the tow path crosses the river to Beningborough.

Cycle Track.

I order to be kept informed I have objected to a proposal by City of York Council to extend the cycle track which presently runs from the City Centre to St Oswald's road. The proposal which has not yet reached the formal planning stage is to extend the existing cycle track through the wet land area adjacent to the river as far as Landing Lane. The effect of this would be encourage an increase of cycle traffic crossing the approach to the club house where a number of near misses have taken place already.

Also an increase in the number of members of the general public frequenting the wetland area may well pose a security threat to the club and moored craft.

The Chester Boat Company (CBC).

As most members will now be aware the extensive efforts made to oppose the Chester Boat Company setting up shop in the most congested part of the river have come to nothing. The fact remains that CBC still have valid planning consent to establish operations as yet unspecified at Wellington Row. CBC have from the outset stated their intention to operate self drive hire boats on the river Ouse, because York Boat are licensed to have 13 such craft CBC will also demand to have 13, and Wellington Row immediately downstream of Lendal Bridge will be the operating base. As there is insufficient water at summer levels to operate from Wellington Row their stated intention is to

plough dredge the river bed disposing of the spoil into the deeper water off Wellington Row in the navigable channel. A similar operation is stated for the frontage of the City of York rowing club immediately upstream of Lendal Bridge.

While the Boating Association will oppose any further congestion on the river between the three bridges in central York, particularly self drive hire boats and the plough dredging operations, there is little realistic hope of success as everything that CBC has demanded so far has in fact been granted.

A passenger trip boat is reported to have lost control during a turn off the club moorings in early May, grounding fortunately on the opposite bank with no damage to YMYC member craft. As you will be aware there is an agreement, albeit verbal, for passenger trip boats not to turn abreast of the club and its moorings. Anyone with information as to date and identity of this near casualty please let me know.

Supervision of children in the club.

In light of a written complaint the attention of parents is drawn to standing order 15.

Parental or responsible adult supervision is required to avoid accident to children or others, and to prevent annoyance to those members who do not have children.

For those who haven't already registered it's a straightforward record of you and your boats details, which can also include a photo of your boat, and makes any S & R operation more likely to succeed.

The form can easily be filled out on line by accessing <u>www.mcg.gov.uk</u> or by contacting the local office at: Humber MRSC, Limekiln Lane, Bridlington, E. Yorks. Tel. 01262672317

The information is kept in their database for two years and then deleted unless renewed following a reminder. The information is accessible by all the MCA's and so only one registration covers all sea areas.
